Information for the Virtual 29th Constitutional Convention of the Canadian Labour Congress



TO: All Affiliated Unions, Federations of Labour, and Labour Councils

GREETINGS!

The **29th Constitutional Convention of the Canadian Labour Congress** will be held virtually from Wednesday, June 16 to Friday, June 18, 2021, using an exciting, interactive, and secure online platform.

While the pandemic interrupts our ability to travel and meet safely in person, we cannot allow it to hinder our movement.

Like nearly every affiliate, labour council and federation, the Congress delayed regularly scheduled events during 2020 in order to rally the resources of our movement to face the global public health emergency and the resulting impact on our economy and our society. On the recommendation of the Executive Committee, the CLC Canadian Council made the decision to postpone plans for a 2020 in-person convention in Vancouver, and to extend the mandate of the officers until a convention could be safely held. During that time, labour's voice played a crucial role in defending workers and shaping Canada's response to the COVID-19 pandemic.

Now it's time to **define the future**.

The 2021 CLC Virtual Convention will be a convention like no other ... and we hope you will be a part of it. Hosted entirely online on a state-of-the-art platform, the 2021 CLC Virtual Convention will not be a simple Zoom meeting; it will be a virtual simulation of an in-person convention. Hosted live from a studio in our nation's capital, delegates will be beamed onto a virtual convention floor to elect leadership, debate policy, and determine the actions that will set the agenda for Canada's labour movement.

However, the constraints of online meetings will require a more focused convention, with a week's worth of business concentrated into 12 hours of plenary meetings, spread over three days.

Please note that the deadline for submitting regular resolutions and constitutional amendments is closed, and the deadline for receiving credentials is May 16, 2021.

All delegations are encouraged to include equity representation (women, Indigenous workers, workers of colour, workers with disabilities, LGBTQ2SI) and young workers (age 30 or younger). After all, a diverse movement is a stronger movement.

While we cannot meet in person, I look forward to seeing you on our virtual convention floor.

REGISTRATION & CREDENTIALS

IMPORTANT INFORMATION FOR REGISTERING YOUR DELEGATES

Please note: All registration forms previously received for the 2020 Convention will be cancelled. Any paid registration fees will be fully refunded by March 15, 2021. There will be a new registration and payment process for our 2021 virtual Convention.

Please refer to the <u>CLC Constitution</u> for your delegate entitlement and register your delegates with the CLC by May 16, 2021. See Article 10, Section 4, of the CLC Constitution.

- a. The Registration Fee for each delegate is \$150 and may be paid in several ways:
 - Credit card (Visa/Mastercard/American Express): Please send an email to <u>convention@clcctc.ca</u> indicating your wish to pay by credit card and provide your coordinates where a designated CLC staff can contact you to process your payment.
 - **Cheque**: Please address your cheque to Canadian Labour Congress, ATTENTION: CONVENTION OFFICE. Please include the name of the delegate, union and local number.
 - **Email transfers**: Please send to <u>convention@clcctc.ca</u>, using the following security question: "event?" and password: "convention2021" all lower case.

NOTE: Record your confirmation number and send it to <u>convention@clcctc.ca</u> in a follow-up email providing the confirmation number, the name of the delegate(s), union(s), and local number(s).

- c. A copy of the registration form should be retained by the delegate (or the designated alternate) in case of discrepancies.
- d. Each credential form must bear the signature of your organization's presiding officer. If you submit your credential form via email, an electronic signature will be accepted.
- e. There is no fee for alternate delegates.
- f. There will be no refunds after Friday, June 11, 2021.

The deadline for receiving CREDENTIALS is Sunday, May 16, 2021.

VIRTUAL 29TH CONSTITUTIONAL CONVENTION OF THE CANADIAN LABOUR CONGRESS

RESOLUTIONS

The resolution submission process is closed. Resolutions submitted prior to the February 4, 2020 deadline will be available to the delegates no later than May 16, 2021.

Resolutions for the CLC's 29th Triennial Convention were accepted between November 26, 2019, through to February 4, 2020. Prior to the postponement of the 2020 Convention, resolution committees of affiliate representatives were convened to consider all resolutions, develop composite resolutions, and make recommendations to convention delegates. The CLC Canadian Council resolved not to re-open the resolution process for the rescheduled convention.

Only emergency resolutions can be submitted at this point.

Typically, emergency resolutions must address circumstances arising since the resolution deadline, or pertaining to matters that could not have been anticipated before that deadline.

All emergency resolutions will be reviewed by the CLC Canadian Council which has the constitutional authority to decide which ones to bring forward to the convention. The approval of two thirds of convention delegates is required before an emergency resolution can be considered. See <u>Article 11</u>, <u>Section 4.e.</u>, of the CLC Constitution.
